



On the same day a meeting of the Disciplinary and Anti-Ragging Sub-Committee was convened in the Principal's room, where further deliberations took place. A subsequent meeting was held on 17th March 2022 in the Principal's chamber to discuss the integration of the accused student, Kaushik Maity

Investigation and Findings:

The investigation revealed that the accused student, Kaushik Maity appeared for the 6th semester final exams.

The female individual accompanying him was identified as an outsider.

Kaushik Maity confessed his guilt during the investigation and submitted a letter of apology.

Actions Taken:

The Committee recommended measures to prevent such incidents in the future.

Kaushik Maity expressed remorse and apologized for his actions.

Recommendations for Prevention:

Strict warning was given to the student Kaushik Maity

Conclusion:

The Disciplinary and Anti-Ragging Committee thoroughly investigated the matter and took appropriate actions as per the institution's guidelines.


