This Memorandum of Understanding (MoU) is made on 27.05.2024 between Naba Ballygunge Mahavidyalaya and Gana Unnayan Parshad for mutual cooperation on social work and helping within and beyond neighbourhood areas. This document establishes the guiding terms and principles of collaboration between the two organizations:

I. LEGAL FRAMEWORK OF BOTH THE ORGANIZATIONS

The college admits students irrespective of caste, creed and religion and teaches through the medium of English and Bengali according to the syllabus laid by the University of Calcutta, It is represented by the **Principal, Dr. Ayantika Ghosh**, hereinafter referred to as the **FIRST PARTY** (which term or expression shall, unless excluded by or repugnant to the context, be deemed to me and include its successor in office, representatives, administrators, and assigns).

Gana Unnayan Parshad (GUP), a registered Non-govt. Organisation with its office at 28/1B/1 Bose Pukur Road, Kasba, Kolkata- 700042, is now working in 7 districts of West Bengal including Kolkata and West Singhbhum district in Jharkhand State for amelioration of the downtrodden people. GUP always gives much importance on various social burning issues like how to safe-guard the human rights of the most marginalized people, Basic Education for all, Women empowerment and their development, Livelihood development of the street food vendors in Kolkata, Rehabilitation programme for the destitute women and children by running one Short Stay Home and managing one Open Shelter for 25 boys along with 3 outreach centers at three different places in KMC area under Integrated Child Protection Scheme of GoI. GUP has also been running two residential units for continuation of education of identified socio-economically disadvantaged 100 male students in each unit in Kolkata under Sarba Siksha Mission. It is represented by its **Director, Smt Sutapa Sarkar**, hereinafter referred to as the **SECOND PARTY**(which term or expression shall, unless excluded by or repugnant to the context, be deemed to me and include its successor in office, representatives, administrators, and assigns).

Both these organizations will hereafter be referred to as Parties.

II. PURPOSE OF THE AGREEMENT

Both the Parties are pleased to enter into an agreement to establish ties of social and humanitarian cooperation in order to establish a congenial and cordial relationship that would lead to the furtherance of both the institutions and lead to a betterment of society through social work. The grounds on which the collaboration is made are as follows but not limited to:

1. Collaboration in order to render social services so that both parties are provided with support
2. Support children of under-privileged sections of the society with books, study related items and other items of daily necessities.
3. Promote gender-equality and a stress-free, amicable environment for all genders
4. Visits, training and exchange of staff, and students.
5. Co-hosting and participation in conferences, seminars, symposiums, and workshops.
6. Social and cultural programs.
7. Any other academic or social activity that is mutually agreed upon and is beneficial to both.

III. EXECUTION OF THE AGREEMENT

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, the period the sub- agreement will be in effect, and administrative responsibility within each institution.

IV. TERMS AND EXPIRATION OF THE AGREEMENT

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years, it will be mutually extended for the same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination, and expiration of the MoU will not affect the terms of activities ongoing at the time of notification of amendment,

Any additions, changes, or deletion to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

V. NON-EXCLUSIVITY

This agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

VI. SPECIAL PROVISIONS

1. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
2. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
3. Neither party can misuse this MoU by involving the name of the other without the written consent of the other party.
4. There will be no financial involvement by either of the parties


