This Memorandum of Understanding (MoU) sets forth the terms and understanding between Naba Ballygunge Mahavidyalaya (hereinafter referred to as "the College") and Samanny Club (hereinafter referred to as "the Club") regarding the use of the playground owned by the Club by the College for a period of five years from 51 May, 2023, to 2014 April, 2026.



Scope:

The College does not have its own playground and requires a facility for the physical education and sports activities of its students. The Club agrees to permit the use of its playground located at Kasba Samannoy for this purpose under the terms outlined below. Terms and Conditions

Duration: This MoU is valid from 5th May 2023, to 30th April, 2026, inclusive.

Usage:

- The College will have access to the playground on weekdays (Monday to Friday) from 12 noon to 4:00 PM.
- The playground may also be used by the College on weekends and public holidays with prior notice and approval from the Club.

Maintenance:

- The College will ensure that the playground is kept clean and tidy after each use.
- Any damages to the playground or its facilities caused by the College will be repaired at the College's expense.

Safety and Security:

- The College is responsible for the safety and discipline of its students and staff while using the playground.
- The Club will not be held liable for any accidents or injuries that occur during the College's use of the playground.

Termination:

- Either party may terminate this MoU with a three-month written notice to the other party.
- In case of a breach of the terms of this MoU, the affected party has the right to terminate the agreement immediately with written notice.

Dispute Resolution:

- Any disputes arising out of or in connection with this MoU will be resolved amicably through mutual discussions.
- If the dispute remains unresolved, it will be referred to a mutually agreed arbitrator whose decision will be final and binding.

Miscellaneous:

- This MoU constitutes the entire understanding between the parties and supersedes all prior discussions, agreements, or understandings of any kind.
- Any amendments or modifications to this MoU must be in writing and signed by both parties.
