### Legal Framework of Both the Organizations I.

Naba Ballygunge Mahavidyalaya, is an under-graduate and post- graduate college, affiliated with the University of Calcutta and recognized by the UGC 2f and 12B has its campus at 27E, Bosepukur Road, Kasba, Kolkata-700042, West Bengal, India. The college admits students irrespective of caste, creed and religion and teaches through the medium of English and Bengali according to the syllabus laid by the University of Calcutta, It is represented by the Principal, Dr. Ayantika Ghosh, hereinafter referred to as the FIRST PARTY (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will hereafter be referred to as Parties.

MAA Foundation, is a charitable non-profit organisation working diligently and sensitively for the benefit of mankind. Through social work and rendering social services this organization has helped in giving a meaningful life through educating the underprivileged and extending support to anyone in need. A trustee of the organisation is Shri Sobhan Mukherjee, commonly known as "Padman of Kolkata" who supplies sanitary napkins to schools and colleges throughout West Bengal at minimal cost. Having contacted the actor Akshay Kumar in 2018 and subsequently having a liaison with one of the leading sanitary napkins producers, Mr. Mukherjee's motto is to assure that girls and women get comfort, cleanliness and good hygiene.

#### **Purpose of the Agreement** II.

Both the Parties are pleased to enter into an agreement to establish ties of social and humanitarian cooperation in order to establish a congenial and cordial relationship that would lead to the furtherance of both the institutions and lead to a bettermen tof society through social work. The grounds on which the collaboration is made are as follows but not limited to:

- 1. Collaboration in order to render social services so that both parties are provided with support
- 2. Assure women comfort in terms of health and hygiene, especially in providing the girls of our college with sanitary napkins made by women from villages who work to be independent.
- 3. Promote gender-equality and a stress-free, amicable environment for all genders
- 4. Visits, training and exchange of faculty, staff, and students.
- 5. joint educational/vocational courses.
- 6. Co-hosting and participation in conferences, seminars, symposiums, and workshops.
- 7. Social and cultural programs.
- Any other academic or socialactivity that is mutually agreed upon and is beneficial to both.

#### **Execution of the Agreement** III.

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, the period the sub-agreement will be in effect, and administrative responsibility within each institution.

### **Terms and Expiration of the Agreement** IV.

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years, it will be mutually extended for the same period, unless one of the Parties expresses an intention



(by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination, and expiration of the MoU will not affect the tems of activities ongoing at the time of notification of amendment, termination or expiration unless otherwise agreed upon between the Parties.

Any additions, changes, or deletion to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these regresentatives.

# V. Non- Exclusivity

This agreement is a non- exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

# VI. Special Provisions

- 1. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
- 2. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
- 3. Neither party can misuse this MoU by involving the name of the other without the written consent of the other party.
- 4. There will be no financial involvement by either of the parties.

## VII. Disputes

If any disputes arise in respect to the MoU, in that case, both organizations will discuss and settle the matter amicably.
