Framework for specific Agreement

This Memorandum of Understanding ("MOU") is a framework for specific collaborative initiatives to be developed between the two institutions.

Article 2

Areas of Collaboration

Both parties have agreed to explore and implement mutually rewarding initiatives in the following areas of

- 2.1 Online sharing of innovative ideas in Teaching Learning and e- Governance;
- 2.2 Faculty and student mobility.
- 2.3 Joint national/ international seminars/ workshops.
- 2.4 Other academic collaboration, including publications.
- 2.5 Skills based certification / add on certification courses:
 - a) Graphics Design,
 - b) Digital Photography,
 - c) Digital Marketing,
 - d) DSLR Cinematography,
 - e) Video Editing

The name of the skills-based certification or add-on certification courses may be changed in the future, and some other courses may be included with the mutual agreement of these two institutes with the power of this MoU.

Article 3

Development of initiatives

Areas of cooperation will be defined between Naba Ballygunge Mahavidyalaya and Vermillion Institute throughout the duration of the MOU and further agreement of academic agreements of academic collaboration may result for specific collaborative activities.

Neither institution shall have any financial commitments to each other, nor through this MOU, real or implied. Both the parties agree, however, to endeavour to secure government, corporate or other party funding where possible in order to support the collaborative activities covered by the agreement.

Article 4

Confidentiality and Intellectual property rights (IPR) protection

Both the institutions shall respect and retain confidentially in each/ any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the institutions, and not any other / commercial interest.

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Article 5

Location of Activities

1. The Parties agree to implement the programmes stated in Article 2 at Naba Ballygunge Mahavidyalaya and Vermillion Institute.

2. Any changes of the location of the programmes shall be done after the mutual agreement done by the Parties.

Article 7

Financial arrangement

Any cooperation under this MOU is subject to the availability of funding sources and approval of the relevant

Article 8

Duration, Amendment and Termination of the MOU

This MOU will remain in effect for a period of 5 (five) years from the last date of signing. It may be amended at any time by mutual agreement and in writing as an addendum. No legal relationship between the two institutions is implied through this agreement. Either party may terminate for this MOU at any time and for any reason by giving the other party at least three (3) months written notice of its decision.

Article 9 Amendment

- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
- 2) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.

Article 10 Settlement of Disputes

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.
