Seminar Report:

The webinar began with a brief introduction to the theme by the joint convenor of Research and Development Sub-Committee, Naba Ballygunge Mahavidyalaya, Dr Sayantina Dutta. The mic was then handed over to Dr Ayantika Ghosh, Principal, Naba Ballygunge Mahavidyalaya, who delivered the welcome address. She emphasized on the alarming rate in which the cyber threats is increasing, beginning her crisp yet meaningful address thus: "In an era defined by a rapid advancement in technology, our presence in the cyberspace has become ubiquitous." Emphasizing on the need of ethical behavior in the cyberspace, Dr Ghosh stated that this behavior is not just a matter of "personal integrity", but the cornerstone of "safe and equitable cyberspace" wherein "respecting privacy is paramount". The compulsion of safeguarding our personal/confidential data and "honesty and accountability as the bedrock of trust in the cyberspace" whether in online transactions, business, social networking or professional e-communication are the two pillars on which ethical behavior in cyberspace stands, in the words of Dr Ghosh. Then she extended a hearty welcome to the august audience.

Mr. Debojyoti Roy talked of the dire need to pertain to cyber ethics to protect personal information such as login and pass word information, credit card and account information and government and commercial database, because ethics are required also to control unwanted internet mails and spams. In Mr. Roy's words, ethics are needed to prevent plagiarism, student identity theft and the use of copyrighted materials. Unwavering ethics are to be demonstrated to make ICT available and acceptable to all so that fairness in cyberspace is guaranteed. Accessibility of all needs to be kept in mind while designing curriculum, and thus Mr. Roy's conjecture added an important point to the world of academia.



The audience was also informed about some of the fundamental rules of Cyber ethics, like one should not break into someone else's device, one should not harass or stalk others on internet, one should not cyberbully, one should not plagiarize, one should not use filthy offensive language in social networking site. Copyright is a major issue pertaining to ethics in cyberspace, reminded Mr Roy. He added that Section 2 of Copyright Act of India, 1957 declares that "literary work" includes computer programs, tables and complilation including computing database. Dr Roy made clear what is included in the domain of internet under Copyright Law in India, they are: computer database, computer programmes/software, computer layouts design, multimedia works etc. The speech was wrapped up on a hopeful note that security tools enhance cyber protection. Dr Roy ended the webinar with a MCQ interactive session. The students of Naba Ballygunge Mhaavidyalaya actively took part and answered all the questions correctly.


